- The bridge at Langar has been repaired.
- A speed monitoring device is being installed on Cropwell Road, although it may not meet the required criteria.
- Apologies were make for the delay in cutting back the tree at the Barnstone/Langar crossroads this will be followed up.
- The Main Road between Barnstone and Langar is scheduled for resurfacing, though no date has yet been confirmed.
- · Additional funding has been received for road repairs.
- An initial submission has been made for local government reorganisation, with the final submission due in November.

Cllr. Combellack reported that much of her recent work has been taken up by the proposed restructure, with goals and priorities continually changing.

12. Councillors' Comments

Cllr. Crosby reported that most of the "30 for a Reason" signs along Main Road in Barnstone are damaged and need replacing. The Clerk will contact VIA.

Cllr. Brown raised ongoing concerns about HGVs entering Barnstone via the Langar/Bingham crossroads and turning right onto Works Lane. Tarmac has already made their drivers aware. A sign is needed at the crossroads, and the Clerk will report this again to VIA. Cllr. Clarke asked that residents record the registration numbers of any offending vehicles. The Clerk will follow this up.

Cllr. Brown also requested that play equipment for older children be considered for the Works Lane site.

Members of the public are welcome to attend all Parish Council meetings.

There is a 15-minute Open Session at the start of each meeting, during which residents may raise items of interest or ask questions.
