Applicant: Icon Tower Infrastructure Limited

Development: The removal of an existing 13.5m monopole mast and associated compound, and the installation of a replacement base station which includes a 25.5m lattice sharable mast, 6no. of antennas, 2no. dishes, 7no. cabinets, etc. Ancillary development thereto. This is needed as the existing mast cannot support the required equipment to improve connectivity.
