Please remind residents of new COVID-19 rules



New rules regarding social distancing in England were applied on Monday (September 14), meaning that residents should not meet with people from other households socially in groups of more than six.

Following reports of a slight increase in cases in the Borough, we are requesting you continue to share key health messages in your areas to ensure we all play a part in tackling its transmission rate.

We're reminding residents, business owners and all stakeholders to:

- Adhere to the Rule of Six, meaning that you should not meet with people from other households socially in groups of more than six. This applies indoors and outdoors, including in private homes. Education and work settings are unaffected.
- "Hands, Face, Space" which means:
Hands - wash your hands frequently for at least 20 seconds
Face - wear a face covering where required, unless you are exempt
Space - Maintain social distance of at least 2 metres from anyone you don't live with or 1 metre plus additional precautions such as extra ventilation, screens or face coverings
- When eating out at a café, pub or restaurant everyone should provide full and accurate contact details of everyone in your group. This NHS Test and Trace Service is important for tracking and preventing the spread.
- Avoid car sharing but if doing so keep windows open, stick to small groups and wipe down surfaces.
- If you have COVID symptoms, get a test and self-isolate. Symptoms include a fever, a new continuous cough, or loss of your sense of taste or smell. Our teams are working closely with partners to take appropriate action and further communicating these messages across our channels and we will continue to keep you up to speed in line with the data being monitored via the County Council's daily Outbreak Cell.

"It's really important to continue to shop safely and people across Rushcliffe have shown great spirit in recent months supporting their local economies as we all aim to combat the challenges COVID has presented.

"Please support your local traders wherever you shop in the Borough. So many have adapted brilliantly whether continuing to trade or reopening in recent months and we want to support them wherever we can."

The latest safety advice for consumers to shop safe will continue to be signposted to business owners as they adapt to the latest central government guidelines.

Residents encouraged to apply for free trees before September 30!



We're encouraging residents, town and parish councils and groups to make their properties and communities even greener by applying for free trees before September 30.

This is the third year running that we've offered the additions to residents' gardens and outdoor spaces and over 5,700 trees have been distributed since the start of the campaign in 2018.

Crab apple and hazel trees are again available without charge as part of our strategy to provide sustainable environments in line with the Borough's significant housing and employment growth in the next decade.

Households can apply for up to two trees by visiting <http://bit.ly/TreeScheme2020> and applying before the deadline later this month.

Successful applicants will be able to collect the trees from us in the autumn adhering to Covid-19 controls and social distancing and will be contacted directly as to when dates will be available.

The crab apple, or *Malus Sylvestris*, can grow to 12 metres and suit areas of partial shade, whilst hazel trees, or *Corylus Avellane*, are shade tolerant and can also reach up to 12 metres.

We are also offering to supply and plant up to 10 trees per parish this autumn and winter to communities and groups, on land identified with the owner's permission. Find out more information on these locations by emailing media@rushcliffe.gov.uk

Fairham contractor breaks ground on start of £800m development



Work has now begun by a major contractor to start the new £800 million neighbourhood and employment site at Fairham.

Multi-sector construction and civil engineering contractor Winvic Construction Ltd has been appointed to deliver the first phase of infrastructure works which have now begun close to the A453 and Clifton Park and Ride, delivered by Clowes Developments in partnership with Homes England.

A site compound has been installed to begin ground works delivering highway, drainage and utility infrastructure and development will initially be focused around the Nottingham Road part of the site between Clifton and Gotham.

The 600-acre site which we awarded planning permission at the start of 2018 will see up to 3,000 new homes, 1 million square foot of commercial space and a neighbourhood centre as well as community, health and educational facilities.

It also helps us meet Central Government's target of 13,500 new homes in the Borough over the next decade.

New skatepark at Country Park to be designed with local young people



A new skatepark at Rushcliffe Country Park is set to be designed in conjunction with local young people, meeting the needs of future Olympic skateboarders and BMXers.

We have recently advertised the tender to replace the wooden skatepark at the park with a bespoke concrete facility set to be completed in April 2021 and will join other updated facilities in the borough, including The Hook at Lady Bay, East Leake and Radcliffe-on-Trent.

The sport has a unique ability to encourage interests in film and photography, whilst the

experience teenagers gain from building wooden ramps with their friends can progress into careers in civil engineering and architecture.

With social enterprise Skate Nottingham, science education charity Ignite! Futures and Nottingham Trent University, we will now look to maximise this potential by empowering young people to co-design the new facility.

A series of workshops aimed at local 11-18-year-olds as well as older skaters and BMXers, will take place later this year and be facilitated by academic experts in architecture, engineering and sports science and mentored by university students.

The new skatepark will have a 'plaza' style layout, simulating the street furniture utilized in modern skateboarding along with beginner-friendly features, elements designed for BMXers, and materials and sustainable approaches to construction that are sensitive to the Country Park setting.

Our Deputy Leader Cllr Debbie Mason said: "It's heartening to see another wonderful skatepark set to be further developed for thousands of current and future skateboarders to enjoy, building on the success of new sites at Lady Bay, East Leake and Radcliffe-on-Trent in the Borough.

"The concept here at the Country Park again incorporates the chance for those who enjoy the sport to add their creative influence into its final design. The future workshops I am sure will really help engage local skateboarders, creating another site they will make their own and a place they can feel proud they helped shape."

Residents reminded to return electoral canvass forms



We're reminding residents not to lose their voice in local elections by completing their annual canvass form if a reminder letter arrives through the post.

With County Council and Police and Crime Commissioner elections set to take place in the Borough next year, it's a vital opportunity for residents to make sure they can take part by ensuring their details on the electoral register are correct.

If a reminder form arrives at an address, residents must respond by confirming details online at www.householdresponse.com/rushcliffe.

Alternatively, they can complete the paper form and return it in the post using the pre-paid envelope provided.

The form ensures we can keep the register up to date and identify any residents who could be missing out on the chance to vote. Those wishing to register to vote need to visit www.gov.uk/register-to-vote

Police warning after spate of HMRC scam phone calls



Please make your communities aware of a warning issued by Nottinghamshire Police following reports of an Inland Revenue scam which is asking the vulnerable for money or face arrest.

The force has received a number of reports of people receiving calls informing them there is a warrant out for their arrest and, unless they make an immediate payment to HMRC, they will be arrested.

According to members of the force, the fraudsters have been cold calling residents across Nottinghamshire and targeting the most vulnerable in the community.

Officers are requesting that people inform the older generation and any vulnerable friends and family about this scam.

In particular, people are asked to remind others that they'll never receive an email, text message, message in an application such as WhatsApp, or a phone call from HM Revenue and Customs requesting personal or payment information.
